Chirurgion's Office - Comments Sought

March 17, 2015

Proposed change to Corpora - Chirurgion's Office

Currently open for commentary is a proposal for the closure of the office of the chirurgionate. The language for this proposal can be found below. The Board of Directors recognizes that this topic is controversial and would like to emphasize that commentary is being accepted until July 1, 2015, and would strongly recommend that all members forward their opinions for consideration.

Over the last number of years, issues have been brought to the attention of the Board and Society Officers regarding the chirurgionate as it is currently organized. These issues included numerous disputes between chirurgions regarding availability of over-the-counter medications, interactions between chirurgions and contracted EMS personnel at large events, interactions between event participants and chirurgions, and differences between first aid provider credentials available in different states, provinces and countries. The frequency of issues and the potential for liability to the SCA as an organization prompted the President to ask the SCA's insurance carrier to clarify whether the duties of the Society Chirurgion, as described in Corpora, are covered by the SCA's policy. In addition, a request for opinion was made to outside counsel to consider whether the risk of not having an office of the chirurgionate created more liability for the SCA than keeping the existing office of the chirurgionate. The response from the insurance carrier was that the duties of the Society Chirurgion, as defined in Corpora, were not covered under the insurance policy, and there was not an available option for coverage of those duties. The response from outside counsel was that there is more liability to the SCA if the SCA has an office of the chirurgionate. The Board requested that a committee of current chirurgions from across multiple North American kingdoms consider options: revising the existing office; evaluating insurance options specific to that office; eliminating that office. Given the recommendations from that committee, the following Corpora changes are proposed. There is no intention to release the heraldry currently associated with the functions of volunteer first aiders participating in the SCA, nor to prohibit any individual from volunteering as a volunteer first aider. This proposal is driven by issues from the North American branches of the SCA. Non-North American SCA affiliates will need to determine their own needs regarding regulation of provision of first aid.

It has been an eventful month in the Exchequer office. Simon Swanbourne has stepped down from the office, and turned over all of the Exchequer inventory, except the PO Box key, to his contingency deputy, Melannei. At this time it doesn't look like the key will be recovered.

Melannei will be changing the PO Box lock later this month as it is within the Exchequer budget. The files were returned a bit disorganized and we have been going through them to make sure we have all the records. We've gone through 2014. There are a few receipts that seem to have been lost in the transfer, and we have contacted those officers to request help in documenting those purchases.

Our priority now will be to do the year-end report, and then to go through the 2013 and 2012 records in preparation for our book review with the Kingdom Exchequer at the end of the month.

Finance committee decisions made in the past month:

- 1) The finance committee met to set the year's budget. All officer budgets stayed the same except the Baronage and Chamberlain budgets. These budgets will be discussed in greater detail at a later meeting before being finalized. This means that with a few exceptions all Greater Offices have a budget of \$120 with a monthly maximum of \$50 and all Lesser Offices have a budget of \$60 with a monthly maximum of

\$25. The exceptions to this rule are Seneschal with a budget of \$180 and monthly maximum of \$100, and the Equestrian Marshall and Family Activities Coordinator with a budget of \$120 and monthly maximum of \$50, the Chatelaine with a budget of \$250, and the Scribe with a budget of \$400. We will publish a copy of the budget in the next Privy.

2) We will be changing signers on the bank account, due to the change in both Principality and Baronial Exchequers, and the Baronial Seneschal. We will be removing Vernon Pierce and Ralph Balogh and adding Melinda Meeds, Kayla Waldroup, Janet Bianco and Laura McNamar. Melanie Mitchell and Meredith Alden will remain on the account as deputies to the current officers. The Baroness, Cherie Beatie, will also remain on the account.

3) The finance committee agreed to accept the donation of funds that were raised by our Rapier Marshall at Long & Short to put towards the purchase and maintenance of Rapier Equipment.

4) Most of the officer's budgets were left untouched this year. The finance committee appreciates your frugal stewardship of baronial funds but wishes to remind all our officers that your budgets are available to you!

Chamberlain: Absent. Nothing to report this month.

Librarian: Nothing much has changed. Have two books to bring by tonight to see if they are worth being in the library. I've talked with Francesca about getting the big books but just got my car back. I should be able to get

them soon.

As for the scanning and transferring of the books to digital works, that's being a little harder to do. Francesca suggested asking others if they'd be interested in volunteering before going to a place like kinkos. Otherwise, I'll swing by kinkos when I go pick up the books to see what they say.

Fortune verch Thomas volunteered to do the scanning.

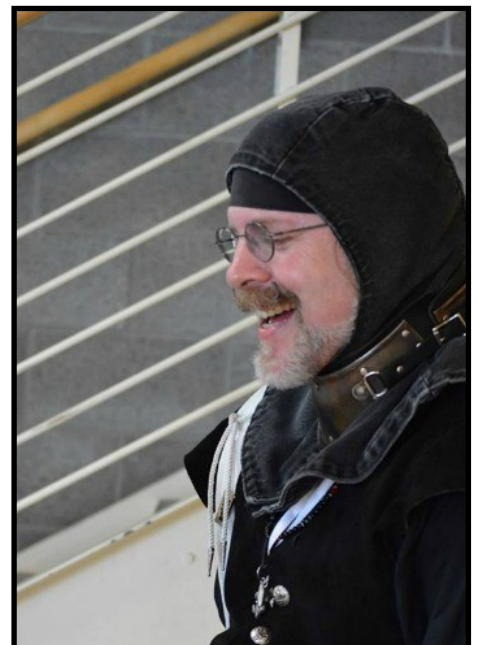

Portable Break-Down Cheese Press

History

Cheese presses have been in use since Roman times and possibly even earlier. In its earliest forms, a cheese press consisted of a ceramic container with holes in the sides and bottom to allow the whey to drain out (see Figure 1). These containers would be stacked one on top of the other, and gravity would do the work of pressing out the whey.

However, this would not be practical for larger sizes of cheese, or for producing “harder” cheeses, as the downward pressure of additional weight involved would crack the ceramic.

As time progressed, mechanical presses were developed for various tasks including pressing olives for oil, grapes for wine, and milk products for cheese. A typical press would involve four simple pieces (see Figure 2 and 3). A base called a drain table would have grooves cut into it to drain off the whey. Above the drain table would be a support frame be built consisting of two uprights and a cross piece spanning between them.

Suspended from the cross piece would be a weight that could be raised and lowered, with some sort of mechanical device such as a lever, screw and nut, or winch. Finally, a cheese form (similar to the ancient cheese presses, having holes on the sides and bottom to allow the escape of the whey) with a “follower” would be placed below the weight.

The weight would press the follower down in to the cheese form, thus pressing out the whey and forming the cheese.

Description

My cheese press was inspired by the period examples that used a screw and nut to raise and lower the weight of the press. My press is much smaller than those typically used in period, because it was designed to be portable. It also breaks down into its component pieces, also to allow for portability. The press is constructed entirely of

walnut, with standard bricks used as the weight.

The base of the drain board was constructed of two pieces of walnut joined together to make a 16" x 16" base. Grooves were carved into the base for draining the whey (see Figure 4). Vertical boards were attached to both sides and the rear to contain the whey and provide additional structural stability. Two mortises were cut into the base for mounting the vertical uprights.

Mortises were also cut into each end of the cross piece.

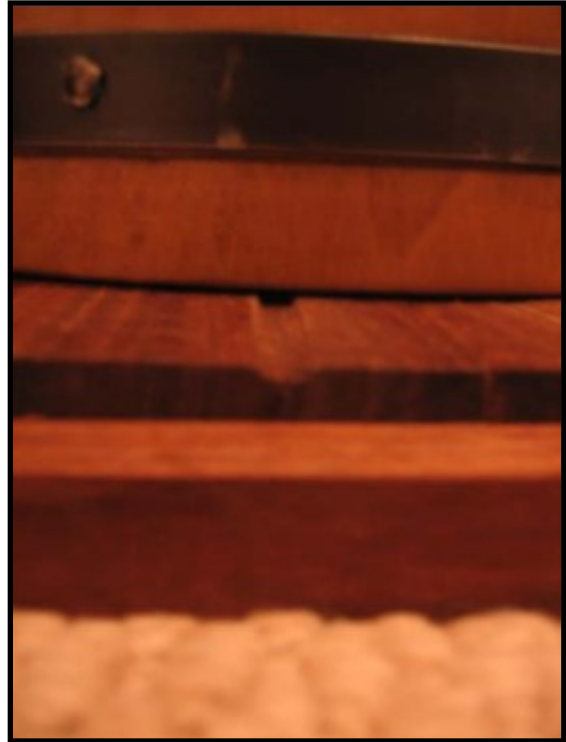


Figure 5 - Mortise and Tenon Joint

Tenons were cut into the vertical uprights on both top and bottom to fit into the mortises on the base and cross piece. This provides an extremely stable, but easily disassembled, structure that can support the weight used in the press (see Figure 5).

In addition to the mortises, a 1" diameter hole was drilled into the center of the cross piece. I obtained a 1" tap and die set for wood. This allowed me to turn a 1" dowel into the screw I needed. I made a "nut" out of two scrap pieces of walnut, and tapped for use with the screw. I also made an 8" x 8" base to attach to the bottom of the screw, which would be used to hold the bricks and press down on the follower (see Figure 6).

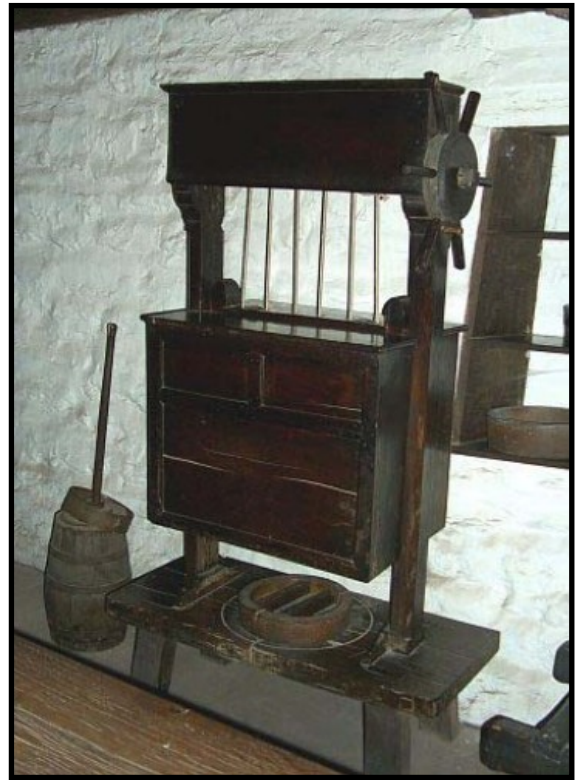
Standard bricks were used as the weights because they are a consistent size and weight, each being 8" long and weighing almost exactly five pounds (to within +/- 1 oz). Their smaller size and weight also lends to the portable aspect of this press. The press as currently designed can accommodate four bricks, or a total of 20 pounds. If the vertical uprights are increased in height, additional weight could be added.
