**Exchequer**

- Greetings!
- I am happy to report that the Year End report has been completed and will be sent to Summits and Kingdom tomorrow. We had a great year due to the valiant fundraising efforts of several members of the barony, and I am not nearly as nervous entering this year as I was this time last year. A summary of the report will be published in the Privy and is also available in hard copy if any wants it.
- The bank balance at the end of the year was \$8787.69. Our current register balance, including uncashed checks, is \$6568.43.
- The financial committee met and hashed out a budget for this year. The officer's budgets shall remain the same as last year, \$60 for lesser offices and \$120 for greater offices, with the exceptions of \$120 for Equestrian, \$180 for Seneschal, and \$200

for Scribe. Additionally, the \$50 insurance for Ceilidh has been added to the budget as this is a recurring expense each year.

- The financial committee is currently researching the checking and savings account options at local banks and credit unions. We would like to add a savings account and will also be changing signatories in April, so this seems like a good time to consider if changing all accounts would be more beneficial to the barony. If anyone has recommendations please pass that on to me via email. If you happen to be at a credit union you'd recommend, please pick up their literature on checking, savings, and CDs and pass that on to me as well!
- After the Kingdom Exchequer's review of the new financial policy, we have made the needed modifications and sent them back for review again. This process should hopefully be done by the next business meeting so that the officers can vote on the new policy and publish it.
- We have finally managed to secure insurance for the Ceilidh site and I would recommend using credit card method for this site in the future. While it is not the Society's preferred method it is definitely more reliable. I spent \$50 on my credit card to do so, and have provided a receipt for the files as proof for my reimbursement. I also requested reimbursement for printer cartridges totaling \$26.99.
- The Principality Exchequer has requested that we immediately remove the previous Principality Exchequer's name from the account. He is willing to wait until

the end of April to have us add him to the account if that will ease the process. I will contact the bank tomorrow to see if removing one person from the account requires less inconvenience all around than adding. After input from the bank the financial committee will determine whether we are simply removing Lucas Langstraat from the account or adding the new Principality Exchequer and my contingency deputy, Vern Pierce.
