Today the Society released the policy regarding requiring proof of vaccination or testing within a 72 hour period for attendance to any activity sponsored by the SCA.

We will be applying this policy in An Tir. This implementation will occur in phases, and you can expect updates regarding this requirement.

As some of you know, the Principality of Tir Righ already has a requirement for proof of vaccination for attendance to any indoor event, and that has been implemented for Fall Crown. King County, Washington has also followed suit and it will be in place for 12th night.

Please read and become familiar with this policy. This will be in place for every SCA activity including, but not limited to, Fighter Practices, Indoor Events, Arts and Sciences night, and Business meetings.

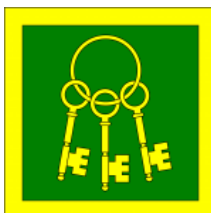

SCA COVID Policy

Board Resolution – COVIDSafe Proof of Fully Vaccinated Status or Negative COVID Test Policy

September 27, 2021

The SCA Board of Directors aims to balance getting Society participants back to doing the things we love with measures that support Kingdoms in protecting all that people have worked so hard for. Our COVIDSafe Resolutions provide a flexible, risk based framework that allows Kingdoms in the United States and Canada to put in place a core set of requirements that event organisers and individuals must adhere to, based on their current environment and public health directions and advice.

As more information becomes available, the Board reviews and updates its resolutions where necessary in line with its responsibility to act diligently, with due care and in good faith. This is never more important than with issues related to the health and safety of our participants.

In line with this approach, based on changing circumstances and updated expert advice, on September 25, 2021, the Board has resolved the following:

Proof of Fully Vaccinated Status or Negative COVID Test

In addition to the existing policy allowing Kingdoms to establish a mask policy, Kingdom Seneschals in consultation with the Crown shall have the discretion to implement the following policy requiring proof of COVID vaccination or a negative COVID test taken within 72 hours of an event start time from all event attendees:

Events are any activities defined in Corpora II.A, "Society Events Defined"

Proof of being fully vaccinated must be in the form of a government issued card (original or photograph) or an electronic record.

Proof of negative COVID test must be issued from a licensed medical provider and presented in such paper form or electronic form that the event staff can verify its authenticity. Letterhead from a medical provider or an email address clearly identifying the medical provider as the sender of an electronic record shall constitute authentic proof.

All persons over the age of 18 must present government issued photo identification along with the proof of being fully vaccinated or a negative COVID test. Parents and guardians of minors must present their own identification along with proof of being fully vaccinated or a negative COVID test for all minors attending an event in their care.





SCA COVID Policy

Proof of vaccination or a negative COVID test shall not be required for children under 12. Children that are aged 3-11 shall wear a mask.

In addition to the normal sanctions process, anyone challenging event staff regarding the enforcement of this COVID policy shall be denied entry to or be immediately removed from the event.

The Kingdom must have one person at a time checking the proof of being fully vaccinated or a negative COVID test at an event. The event organizer, or their designee, shall maintain a list of names and times of the person(s) conducting the check at the entrance. Once the entrance is closed at the event, said person(s) will sign a statement at the bottom of the list of names and times, which reads:

"I have monitored the event entrance at the times noted above, and I have verified that each person entering the event during that time has shown me proper identification, along with either proof of being fully vaccinated or a negative COVID test taken within 72 hours of the start of the event."

Kingdom Seneschals shall notify the Society Seneschal where local, state, provincial, or national law supersedes this policy.

This policy shall not apply to Lochac and Drachenwald.

Terra Pomaria,

In the above policy, "Event" applies to all official 1 n-person Baronial events and gatherings such as fighter practice, scribal night, Ceilidh, and other large events being planned. Officers and marshals should enforce this policy during gatherings and all attendees should adhere to the directed safety guidelines for vaccine status, testing, mask-wearing, and social distancing.

Our Baron and Baronesa rely on the skill and hard work of more than 20 officers and deputies performing regular duties that allow us to hold events, manage our finances, reach out to the community and welcome newcomers, build history and create memories. Without these key roles filled, we can only fulfill a portion of our organization's purpose.

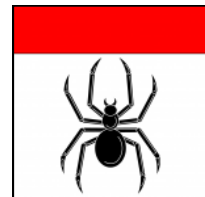
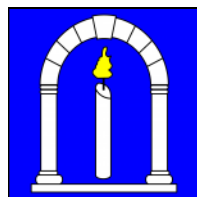
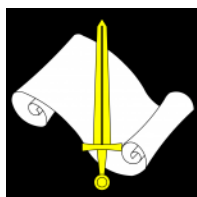
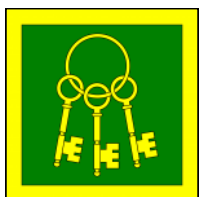
We need fresh faces with new ideas to learn these roles as officers and deputies and to carry the responsibility of each. Are you willing to step forward and help take our Barony into the future?

DEMO COORDINATOR - *Coordinates public demonstrations for the local group.* Keyword: "coordinate." Arrange for locations, fighters, displays, games, and handouts and brochures. The more demos held increases our group's exposure and sparks the interest of adults and children - what we need to continue as an organization!

GOLD KEY - *Gold Key manages several pieces of clothing that can be loaned out at events so that those without period clothing can still feel as part of the event.* Alynna Trewpenny's time as Gold Key is done and she is seeking a successor. Ensuring that tubs of clothing are available for newcomers or event attendees who need additional items is very important to the immersion into a medieval event. Proper clothing is a doorway to feeling like one is in the Middle Ages! Gold Key also ensures damaged clothing is repaired using their own skills or seeking help from other skills members of the populace.

MINISTER OF LISTS - *The Lists involve who is in what tournament, who is their opponent, who is eligible for said tournament, etc. The Minister of the Lists is the person that coordinates all of that information during the event and reports the results.* This role is critical when Terra Pomaria hosts championships and tournaments and includes all marshal competitions in heavy combat, rapier, archery, and thrown weapons. Without it, the organization and pace of these events could get seriously bogged down and confused.

YOUTH ARMORED COMBAT - *Also known as YAC. This person is the local authority for youth combat activities.* YAC marshals must demonstrate the ability to supervise youth combatants, inspect youth weapons and armor, and judge a youth combatants authorization. To foster interest and skill in marshal

events at a young age means our Barony will have capable and honorable combatants for many years.

MINISTER OF ARTS & SCIENCE - *The Minister of the Arts and Sciences coordinates activities associated with the different arts and sciences of the pre 1600s. Some times these are at events and other times they coordinate other gatherings to work on various projects.* Rowan Spirit Walker's obligation in this role is completed and we need to find another person to take the reins. Terra Pomaria is recognized across our Kingdom and the Known World for its artisans and craftsmen. This skill and talent begins by learning new things here at home during A&S gatherings and classes at events. Coordination of trainers is critical to the passing of knowledge and fostering a love of learning about the medieval world.

MINISTER OF THE GRETE BOOK - *The Minister of the Grete Boke keeps a running archive of the Barony's history.* Terra Pomaria's 37 years of history is full of great stories, proud triumph, and success in the arts and on the field. Recording and maintaining that history is essential so that future generations know where our Barony came from.

WEB MINISTER - *The Web Minister is the person responsible for the Terra Pomaria website, and for the online content of the Barony.* Adele Neuton needs to hand off this position to another person to focus on life's priorities. Ensuring that the information most easily accessed by the public and the populace is up to date and accurate. Training to perform this duty is free, available, and quickly learned.
